### Executive Director Message





**NEW BRANDING** and a year of depth and breadth for Region Five Development Commission (R5DC) and our 501c3 affiliate organization - the North Central Economic Development Association (NCEDA). This publication shares tangible work that addresses our 5-county regional critical issues that fulfill the R5DC strategic plan and annual work plan. Through many partnerships, the R5DC team delivered planning and project management in the areas of 5 different lending programs associated with a high level of technical assistance, in addition to <u>Transportation</u> and <u>Community Development</u> initiatives.

To further address access to capital - we are proud that NCEDA is one of the state's leading lenders for the <u>Entrepreneur Lending Program</u> sponsored by MN Dept of Employment and Economic Development providing loans to businesses that are unable to access traditional sources of capital. This program compliments our <u>Microlending and Gap/participation lending</u>.

After 7 years of effort by many regional partners, we completed the <u>Solar Schools</u> project that also progress strategies within the region's comprehensive economic development strategy - <u>CREDS</u>.

Our planning and facilitation intensified our commitment to meet the needs of underserved residents and advancing Equitable Economic Ecosystems through the <u>Welcoming Communities</u> program supported by Sourcewell, the Blandin Foundation and Northwest Area Foundation (NWAF).

This year, we made gains in growing our region's local food economy while improving veteran services via the VetCSA, funded by the Minnesota Department of Veterans Affairs, and through the RxCSA, with partners at Sprout and Happy Dancing Turtle. These programs address important issues such as the opioid and mental health crisis. We successfully secured resources from the MN Department of Agriculture's Good Food Access Program that allow us to partner with several technical assistance experts to deliver training requested by the region's food cooperatives.

The placemaking work has been exhilarating and staff were contracted by our partners at Sprout to manage outreach and coordination of artists for the wonderful new <u>À la cARTe project</u>. We are pleased to have co-facilitated and completed an extensive comprehensive planning process with the City of Brainerd, alongside partners at Sourcewell. We were thrilled that the 30+ year mutually beneficial partnership with MnDOT progressed the <u>Regional Transportation Coordination Council</u> implementation.

There are WELL over a dozen other initiatives being led by R5DC & NCEDA not mentioned above, so stay tuned to our upcoming podcasts to learn more about our services, partnerships and regional impacts. We all know that change follows relational lines and we continue to build relationships that effect positive change for our region.

## **Financial** Highlights

#### FY2019 Actual Revenue by Source



Region Five Development Commission's financial statements for fiscal year 2019 were audited by Schlenner Wenner & Co. An unmodified opinion was expressed.

\*As the Commission completed this year, its General Fund reported a combined fund balance of \$2,933,762. This is an increase of \$2,093,951 from the prior year. This increase is primarily due to debt proceeds related to the Solar Schools Project.

The assets and deferred outflows of resources of the Commission exceeded its liabilities and deferred inflows of resources at the close of the fiscal year by \$1,684,177 (net position), of which \$1,567,910 (93.10 percent) is restricted in use.

The governmental activities closed the fiscal year with a net position of \$116,267, which was entirely unrestricted.

#### **Bush Foundation Creative Community Cohort**

R5DC is one of 40 organizations from North Dakota, South Dakota, Minnesota and the 23 Native nations that share the geography selected by the Bush Foundation for its commitment to making art and culture central to problem solving. "We are thrilled to be a part of the Foundation's second Community Creativity Cohort. We believe this experience will be invaluable in helping address the issues that are of most concern to our region.", stated R5DC Executive Director Cheryal Hills.

Each member of the cohort will receive a general operating support grant of \$100,000 over a three-year period and access to other funds to help them improve their work and strengthen their organizations.





### Welcoming Communities

R5DC's Welcoming Communities program is focused onworkforceattractionandexpandingculturalagility for individuals, organizations, and communities. Thanks to funding from the Blandin Foundation, Northwest Area Foundation, and Sourcewell, R5DC has conducted Intercultural Development Inventory (IDI) assessments and training to help advance the regional goals of workforce attraction. Additional funding from Sourcewell also allowed R5DC to pilot a Welcoming Communities Advocacy Group (WCAG) with GoNorth - an organization made up of the cities of Fifty Lakes, Emily and three townships. The WCAG is made up of elected officials, public sector, private business, non-profits and students. This 18 month project is designed to help communities increase intercultural agility and ability to bridge differences while building on the community's assets. #### **One Watershed-One Plan**

The Wadena County Soil and Water Conservation District (SWCD) is undertaking the development of the Redeye River Watershed-based plan - consistent with the One Watershed; One Planvision and program grant requirements adopted by the Board of Water and Soil Resources (BWSR). R5DC facilitates the Redeye River Watershed Advisory Committee as they progress through the planning process. The committee has analyzed baseline watershed related data, identified a comprehensive list of issues facing the watershed, created a prioritized list of watershed related issues, developed issue statements describing the issues that exist, and developed a vision statement for the watershed.

The committee is currently identifying long term goals and objectives based on the analysis and issues already identified. Next steps include presenting the draft plan to the Policy Committee, receiving public comments, and submitting the final plan to the state for adoption process.

#### Broadband

In 2019, R5DC received \$125,000.00 of investment from Sourcewell to continue regional broadband expansion. Investment decisions made are based on highest need and highest impact. To date, \$500,000 over the last 5 years has leveraged over \$16 million in State funding to expand broadband, led by Consolidated Telecommunications Company, the West Central Telephone Association and local municipalities to offer broadband to the last miles of Crow Wing, Cass, Morrison, Todd and Wadena counties.



## Solar Schools Project

R5DC partnered with New Energy Equity and Rural Renewable Energy Alliance to develop six solar array systems, totaling 1.5 MW, for four schools in central Minnesota. This project extends across five counties, allows schools to save money on their energy bill and creates STEAM curriculum to enhance student learning. Project funding provided by customers of Xcel Energy through a grant from the Renewable Development Fund (RDF).



The Solar Schools project generated an estimated **\$7.8 million** of economic activity in the region. Of this, **\$3.2 million** was labor income paid to area residents. The project also supported an estimated **88** jobs.



Sites include Pine River-Backus School District, Pequot Lakes High School, Central Lakes College (CLC) Staples Main Campus, CLC Staples Ag Center, CLC Staples West Campus and CLC Brainerd Campus.

### **Priority Projects**

The R5DC CREDS Strategy Committee selected five projects to include as Priority Projects in the Comprehensive Regional Economic Development Strategy (CREDS). The 2019 Priority Projects are:

**Welcoming Communities Advocacy Groups – R5DC**: In an effort to gain cultural competency, and to be more welcoming to people living within and moving into our communities, Welcoming Communities Advocacy Groups are (WCAG) are being formed in seven communities. Groups are working side by side for 18 months to look at systems, practices and policies that might be changed to improve equity and inclusion for all and then implementing a project or program in each community to help work towards that goal.

**VetCSA**: This program serves 50 veterans residing in the counties of Cass, Crow Wing, Morrison, Todd or Wadena. Participating veterans will receive a Community Supported Agriculture (CSA) food package twice per month, for one year at no cost. Cooking demonstrations and classes will be offered monthly by local food experts, chefs and nutrition educators.

**Children's Museum**: The children's museum brings together the region's children and families in shared experiences that are grounded locally and open onto the wider world. Dynamic, material-rich environments, exhibits, events, and programs engage children in the joy of play and the wonder of learning. Region 5 children's museum and its partners envision a more vibrant and connected region because all children enjoy the supportive relationships, expanding opportunities, and well-being they need to thrive.

**Regional Transportation Coordinating Council (RTCC) Implementation**: Through the RTCC, there will be formalized increased coordination between providers and service agencies which will result in an efficient system of transportation options, providing customers easier access to services that meet their transportation needs with a focus on those who need it most.

**Good Food Access Program**: Technical assistance is being offered to employees and operators of small food retailers through a grant from the Minnesota Department of Agriculture's Good Food Access Program. Session topics include Market Expansion, WealthWorks evaulation, HR Retention Strategies, Grant Writing, Board Development, Business and Succession Planning, Health - Education and Policy, Technology, and Financing. ## Transportation

### RTCC

R5DC continues to serve as the coordinator of the five-county Regional Transportation Coordinating Council (RTCC) for the counties of Cass, Crow Wing, Morrison, Todd and Wadena. The goal of this council is to fill transportation gaps, streamline access to transportation and provide individuals with more options of where and when to travel. This improves mobility for the "transportation disadvantaged"— older adults, individuals with disabilities, individuals with low income and/or military veterans.

June of 2019 marked the end of the initial planning phase (Phase 1) for RTCC and we are now in Phase 2 of the RTCC which is also referred to as the implementation phase. The timeline for RTCC Phase 2 will be from July 1st, 2019 – June 30th, 2020. In Phase 2, the main focus is to use information gathered from Phase 1, such as public input, goals, objectives and to implement those into the region in hopes of creating a seamless transportation system. Phase 2 also includes the formation of the RTCC Board which will be compromised of 21 members from around the region, ranging from County Commissioners to County Veteran Service Officers and Public Transit Providers.



### TAC

R5DC staff continues to meet quarterly with the Region Five Transportation Advisory Council (TAC). The TAC is a committee of the Region Five Development Commission serving Wadena, Crow Wing, Todd, Morrison and Cass Counties.

The TAC is charged with addressing issues of local and regional significance; reviewing and guiding the development of various transportation plans and studies effecting the region; providing input to the Minnesota Department of Transportation in planning, policy, and project development; and recommending a prioritized lists of transportation projects seeking federal aid through the Central Minnesota Area Transportation Partnership (ATP).



### SRTS

In cooperation with the Walker-Hackensack-Akeley (WHA) school district, R5DC is in the process of developing the WHA SRTS plan. Staff is working with local partners to develop the local planning team, administer, collect and analyze information received through a parent survey, an in-class student tally, a walking audit and an analysis of issues and barriers. After assessing issues and barriers, the planning team guided by Region Five will develop several goals and recommendations to be considered by the school board. Each goal will be based on the 6 "E" framework, which include Engineering, Education, Encouragement, Enforcement, Equity, and Evaluation.
