Region Five Development Commission's financial statements for fiscal year 2022 were audited by Schlenner Wenner & Co. An unqualified opinion was expressed.

#### FINANCIAL HIGHLIGHTS:

\*The assets and deferred outflows of resources of the Commission exceeded its liabilities and deferred inflows of resources at the close of the fiscal year by \$3,690,587 (net position), of which 48.7 percent is restricted in use.

\*At the close of the fiscal year, the General Fund reported an ending fund balance of \$2,511,597, an increase of \$26,005 in comparison with the prior year. Of this balance \$1,485,902 is nonspendable, \$45,817 is assigned, and \$979,878 is available for spending at the Commission's discretion (unassigned fund balance).

## **Economic Development**



Upsala Senior Living is a 20-bed licensed assisted living community serving area residents with a newly constructed building, opening its doors and welcoming their first residents in August 2022.

R5DC's non-profit lending arm, NCEDA, was able to help with a new business startup loan for equipment and working capital using the Revolving Loan Fund program. This funding is available through U.S. Economic Development Administration.

In her role, she supports the rural workforce sector to attract and retain untapped workers (BIPOC, LGBTQIA+, youth, women, veterans, previously incarcerated etc.) through the Inclusive Workforce Employer Designation (I-WE) – in direct partnership with Community Workforce Inclusion Committee, Rural Minnesota CEP and the Regional Workforce Alliance. Mentor JSC projects/programs in ways that offer workforce attraction and retention, and quality of life.

broadband

military connections

### regional transportation coordination council

R5DC continues to serve as the coordinator of the five-county Regional Transportation Coordinating Council (RTCC) for the counties of Cass, Crow Wing, Morrison, Todd and Wadena. The goal of this council is to fill transportation gaps, streamline access to transportation and provide individuals with more options of where and when to travel. This improves mobility for the "transportation disadvantaged"— older adults, individuals with disabilities, individuals with low income and/or military veterans.

Successes of the Region Five RTCC during Phase 4 included: holding productive and discussion driven board and subcommittee meetings, created and published a provider directory, connected with new providers within the region, completed GIS mapping of all public providers in the region with the assistance of Mn Department of Transportation, and applied and awarded AARP Community Challenge Grant To learn more about the successes of the R5RTCC please visit regionfive.org/RTCC.

#### transportation advisory council

Continuing its more than 40-year relationship, assisting the Minnesota Department of Transportation (MNDOT), the Region Five Transportation Advisory Council (TAC) is charged with addressing issues of local and regional significance; reviewing and guiding the development of various transportation plans and studies effecting the region; providing input to the Minnesota Department of Transportation in planning, policy, and project development; and recommending a prioritized lists of transportation projects seeking federal aid through the Central Minnesota Area Transportation.

safe routes to school

R5DC worked alongside the Verndale school district, to craft a SRTS planning document that seeks to increase safety, health and well-being of students by improving the walking and biking opportunities and by addressing any potential risks, issues and barriers that may exist.

After assessing issues and barriers, the planning team guided by Region Five developed several goals and recommendations to be considered by the school board. Each goal will be based on the 6 "E" framework, which include Engineering, Education, Encouragement, Enforcement, Equity, and Evaluation.





# aarp community challenge grant

The AARP Community Challenge provides small grants to fund quick-action projects that can help communities become more livable for people of all ages. R5DC provided transit passes, transit training, and memberships to local health and wellness center to approximately 100 seniors/ veterans/ low-income individuals who may be facing challenges caused by COVID in the five-county region. The enrolled individuals ranged in age from 12 years old to 85 years old and each were supplied with transit passes. Due to COVID, we conducted transit training via video and were able to create "How to Ride the Bus" videos for each county in the region. The grant ran from July 2021 - December 2021.

## **Transportation Planning**

#### transportation coordination

R5DC assists MNDOT and the region through the facilitation of multi-jurisdictional transportation discussions – no other topic in transportation is as important as Safety. While each community, and each jurisdiction has its own unique challenges, and opportunities, they all strive to provide safe transportation. Therefore, staff has been engaged in local efforts to coordinate locally to find innovative solutions to safety concerns on a regional basis.

#### local human services transit coordination plan

The purpose of the Local Coordination Plan (LCP) is to evaluate existing transportation providers, identify the unmet needs and services, and establish transportation related goals for Region Five. This documentation fulfills planning requirements for the Fixing America's Surface Transportation Act (FAST Act) signed into law December 4, 2015.

The local human service transportation coordination planning process encourages participation from all local stakeholders and the public in the region, especially within target populations. The purpose of this process is to improve human service and public transportation for older adults, individuals with disabilities, and individuals with low incomes through coordinated transportation.

The plan contains demographic conditions, inventory of existing transportation providers, gaps in service, and unmet needs throughout the region that have been identified though analysis, committee input, and stakeholder outreach, included a 30 day public review as well as a technical review my MNDOT and was approved in June 2022.

toward zero deaths

This year, R5DC staff emphasized involvement with the Brainerd Lakes Area Towards Zero Deaths coalition which is a part of the larger State (MNDOT) program known as Towards Zero Deaths (TZD). TZD to create a culture for which traffic fatalities and serious injuries are no longer acceptable through the integrated application of education, engineering, enforcement, and emergency medical and trauma services.

In addition, staff is working with MnDOT, local law enforcement, Emergency services such as fire and EMS as well as local elected leaders to develop additional coalitions in the other counties of the region currently not served.
