### **Legislative Charge**

Minnesota Statutes 2024, section 124D.992 designates an annual distribution of School Library Aid to school districts and charter schools. The statute reads:

"Subdivision 1. School library aid. For fiscal year 2024 and later, school library aid for a district equals the greater of \$16.11 times the district's adjusted pupil units for the school year or \$40,000. For fiscal year 2024 and later, school library aid for a charter school equals the greater of \$16.11 times the charter school's adjusted pupil units for the school year or \$20,000.

Subd. 1a. State school librarian. In fiscal year 2026 and each fiscal year thereafter, the Department of Education may retain up to \$130,000 of the amount appropriated for school library aid under this section for the costs of the state school librarian under section 127A.151. The aid for each school district and charter school under subdivision 1 must be reduced proportionately. The reduction in aid under this subdivision must be applied to the current year aid payment.

Subd. 2. Uses of school library aid. School library aid must be reserved and used for directly funding the costs of the following purposes within a library:

- (1) the salaries and benefits of a school library media specialist;
- (2) electronic, computer, and audiovisual equipment;
- (3) information technology infrastructure and digital tools;
- (4) electronic and material resources; or
- (5) furniture, equipment, or supplies.

Subd. 3. Report. By January 15, 2025, and annually thereafter, the commissioner of education must report to the chairs and ranking minority members of the legislative committees with jurisdiction over kindergarten through grade 12 education on how school districts and charter schools used aid under this section in the previous fiscal year. In preparing the report, the commissioner may use information available from the uniform financial accounting and reporting system."

#### Introduction

As this is an automatic distribution of state aid entitlement, with no application process, the distribution of School Library Aid was assigned to the School Finance division within the Minnesota Department of Education (MDE).

Estimated amounts of School Library Aid for school districts and charter schools were posted to the MDE Data Center under Data Reports and Analytics > School Finance Spreadsheet > General Education (or, > Charter Schools) > Subcategory "School Library Aid." Guidance on using the aid was provided to school districts and charter schools through a <u>Frequently Asked</u> <u>Questions</u> document and additional technical assistance from both State Library Services and School Finance staff at MDE.

School districts and charter schools reported school library aid expenditures through the Uniform Financial Accounting Reporting Standards (UFARS). All Minnesota school districts and charter schools must report their audited financial data for the previous fiscal year to the Minnesota Department of Education (MDE) by November 30 and submit an audited financial statement to MDE by December 31 (Minnesota Statutes 2024, section 123B.77, subdivision 3).

### Analysis

This report shows total expenditures reported in UFARS Finance Code 343 School Library Aid.

In Fiscal Year (FY) 24, 296 public school districts and 111 charter school districts reported a total of \$19,223,401.59 in school library aid expenditures.

To summarize the usage of the school library aid, the 37 allowable UFARS object codes have been grouped by the five categories of school library aid outlined in statute. See **Appendix A** for the full list of UFARS object codes included in each use category, and **Appendix B** for expenditures by school district or charter school.

#### FY24 School Library Aid Expenditures, by Statutory Use



Tables 2 through 4 group the districts reporting school library aid expenditures by strata: three strata for metroarea districts, three for non-metro districts by student enrollment, and one stratum for charter schools. These tables show the total expenditures and district-average expenditures for each category of statutory use.

The category most utilized in FY24 school library aid spending—salaries and wages—is further divided in Table 2 by licensed staff salaries (UFARS object code 143), non-licensed staff salaries (UFARS object code 144), and all other project codes pertaining to salaries and benefits.

### Conclusion

In this first year of the distribution of school library aid, districts primarily used these funds for salaries and benefits for library staff, followed by library materials and furniture, equipment, and supplies. Relatively few districts chose to spend school library aid on the two categories related to technology software and hardware.
