Introduction

Laws of Minnesota 2020, Chapter 82, section 5, subdivision 12a-b requires all law enforcement agencies that maintain or use an Unmanned Aerial Vehicle (UAV), also known as a drone, to report the following data by Jan. 15 regarding the prior calendar year to the Minnesota Department of Public Safety (DPS):

- The number of times a UAV was deployed without a search warrant.
- The date of each deployment.
- The authorized use for each deployment (see Minnesota Statute § 626.19, subdivision 3).
- The total cost of the agency's UAV program.

This report fulfills the further requirement that DPS compile the data into a report for the legislature to be posted on the department's website.

Background

Laws of Minnesota 2020, Chapter 82, was signed into law on May 16, 2020.

The BCA developed and provided a submittal form to law enforcement agencies in 2020 that enables law enforcement agencies that maintain or use an Unmanned Aerial Vehicle (UAV) to report the data required by statute in a uniform manner.

The information provided to and compiled by the Minnesota Bureau of Criminal Apprehension (BCA) in this report covers the reporting period Jan. 1, 2023, through Dec. 31, 2023.

In 2023, Minnesota law enforcement agencies reported a total of 4,326 UAV uses in circumstances where a warrant is not required. That is up 41 percent from the 3,076 reported in 2022. Information on individual agency uses are provided below in summary and later in the report for each reason code.



Program costs

In 2023, Minnesota law enforcement agencies spent a total of \$1,065,677.32 on UAV agency programs. That is up 65 percent from the \$646,531.24 total in 2022. Information on individual agency costs are provided below.
