Dear Governor Perpich:

Enclosed herewith is my report as secretary-general manager for the Minnesota State Agricultural Society's fiscal year which ended October 31, 1983.

Over a period of 99 years, the Minnesota State Fair has methodically gone about the task of setting in place one of America's finest exposition facilities . . . strong, functional buildings; broad, concentric avenues of commerce and display; open vistas of trees, flowers and parks . . . a busy, yet comfortable environment for all who attend. It is this singular accomplishment that first impacts the visual senses of a new visitor and creates an awareness of permanence and cohesion.

Far more important, however, are the strategic elements of quality programming, solid family entertainment, education and enterprise promotion that form the ultimate essence of this institution. These factors motivate pride and self-esteem for all Minnesotans and generate the "tradition of excellence" for which the Minnesota State Fair is known throughout the exposition industry.

People of varied backgrounds from the Upper Midwest each year meet and share experiences at the "Great Minnesota Get Together." A walk of less than one block allows a visitor to touch a new farm tractor, see an award-winning sculpture, taste a fresh milk shake, hear a country music concert and smell newly-made popcorn. Within that same block are exhibits of 4-H work, a parade of high school marching bands, a children's theater and a spaghetti dinner. The magic is in diversity and quality, wrapped in the bright, blue ribbon of value.

The fairgrounds with all its functional amenities is the framework within which this comprehensive program is presented. It is, therefore, and extremely important adjunct to the continuing success of the exposition. It follows then that upkeep, general maintenance and well-planned improvements to the physical plant are an absolute necessity to viability and development.

Where do the funds come from that are necessary for the continued maintenance and improvement of this facility? They do not come out of tax dollars, legislative appropriations or from any other form of government subsidy. Rather they are generated and drawn directly from the outside gate, Grandstand and space rental income of the fair. Over the past five years (1979-1983), the Society has invested \$5,650,000 in plant improvements and maintenance. A three-year project of major consequence, the replacement of Coliseum roofing cost just under \$500,000 to complete in 1983.

During the five-year period, the fair has paid into the state treasury in the form of sales, use and real estate taxes, \$950,000 . . . an annual average of \$190,000. This sum is unique in that it is over two and one-half times greater than the annual average profit of the exposition.

Citizens of Minnesota, who over these many years have given unqualified support to the fair, should take great pride in the fact that they have sustained an enterprise of distinct character . . . an enterprise of their invention which stands independent of financial subsidy and political manipulation. Your board and staff pledge their continued efforts in protecting this unique status.

#### INTRODUCTION

Per Chapter 37, Minnesota Statutes, the Minnesota State Agricultural Society is charged with the conduct of an annual State Fair as well as control and management of the State Fairgrounds.

The statutes specify that the Society's secretary must provide a report to the governor for the fiscal year ending October 31 on or before December 31 each year; material that follows satisfies this requirement. The statutes also require that a summary of the legislative auditor's annual examination of the Society's books and accounts be appended to the annual report to the governor prior to printing and public distribution; this is done as soon as the auditor's report is available.

#### ORGANIZATION

Policy for the administration of the State Fair is set by the board of managers of the Minnesota State Agricultural Society – governing body of the fair. The board of managers is composed of 10 members – one representative from each of the society's nine regional districts and a president. Members of the board are elected by authorized delegates of the State Agricultural Society, representing the state's county fair agricultural societies and various agribusiness, livestock breed and crop associations.

The president, nominated from members of the board, is elected by the society to serve a term of one year. The board's two vice presidents, representing the society's fourth and fifth districts (St. Paul and Minneapolis) are elected to alternating two year terms. Managers on the board are elected to alternating terms of three years.

In addition to setting policy, the board appoints the fair's chief operation officer (general manager), coordinates various departments and deals with specific areas of operation through a number of committees.

Policy for the management of the State Fair, set by the board of managers, is implemented by the general manager, chief operating officer of the exposition. The general manager, in turn, operates through a year-around staff of 40 people. Full-time personnel are joined by a seasonal staff that swell to over 2,000 by fair-time.

The full-time staff handles duties such as building, grounds and vehicle maintenance along with security services and off-season events. Administrative functions include accounting, amusements, competitive events, promotion and space rental.

The variety of functions necessary to the staging of the annual exposition are organized under three divisions (see chart on page 4), headed either by an assistant manager or the general manager. Related activities are further divided into groups of specific responsibilities. Many of these areas are State Fair departments, headed by superintendents. The divisional system is a flexible arrangement and was modified recently to improve efficiency; the chart on page 4 reflects those modifications.

#### ANNUAL MEETING MINNESOTA STATE AGRICULTURAL SOCIETY Radisson South Hotel – Bloomington, Minnesota

#### January 16-18, 1983

The 124th annual meeting of the Minnesota State Agricultural Society got underway with a day-long registration period on Sunday, January 16 (registration continued Monday, January 17 and Tuesday, January 18). First general business session, chaired by President Scow, was held at 9:15 a.m. Monday for the purpose of appointing credentials and resolutions committees; these committees met to conduct business at 10:15 a.m. Monday.

At 3:00 p.m. Monday, delegates from the second and eight regional districts met in caucus to certify nominees for election to the society's board of managers on January 18.

At 1:00 p.m. Tuesday, members of the society again met in general session. President Scow called the meeting to order; reports of Secretary-General Manager Heffron and Finance Director Roehl were presented and accepted.

Remarks were given by Steve Koziolek, Wells, Minnesota FFA president and Pam Langenfeld, Hastings, Minnesota 4-H Ambassador.

Following credentials committee report was presented by William Elliott, Albert Lea, and accepted by the membership:

"All credential blanks for state-wide societies and associations submitted to the State Agricultural Society have been viewed by the committee and approved by them, with the following exceptions: MN Farmer's Union (did not file a report with the Secretary of State). MN Honey Producers (formerly MN Beekeepers, did not file a report with the Secretary of State). NOTE: Committee recommended that the statute be examined and if possible, legislative action be taken to (1) define delegate/alternate duplication procedures and (2) update legal titles of statewide associations."

Resolutions committee report was given by William Berg, Perley. The following resolutions were adopted by the membership:

**Resolution No. 1:** Resolved, that we express our special thanks to the staff of the Radisson South Hotel and responsible members of the State Fair staff for valuable services and cooperation rendered in conducting the 124th annual meeting of the Minnesota State Agricultural Society.

**Resolution No. 2:** Resolved, that we extend our thanks to those who made the 1982 State Fair successful namely, all State Fair employees; commercial exhibitiors and concessionaires; competitive exhibitors; suppliers and purveyors; county fairs; youth and school groups; chambers of commerce and mayors; the State Fair's advertising agency; implement dealers and manufacturers; entertainers, their agents and managers; State Fair superintendents, the secretary-general manager and board of managers; and especially the people of Minnesota and the Upper Midwest for their continued support of the Minnesota State Fair through their attendance and participation.

**Resolution No. 3:** Resolved, that we express our sincere gratitude to county fair associations, exhibit and concession groups and other friends of the State Fair whose legislative contact work aided the passage of legislation correcting certain inequities and providing for more efficient operation of

the exposition.

**Resolution No. 4:** Resolved, that we hereby thank our secretary-general manager, Mike Heffron, and we commend him for his efforts resulting in the passage of the State Fair bills during the 1982 legislative session. His political acumen guaranteed their passage. Be it further resolved that we hereby express our deepest appreciation to the several legislative sponsors of the State Fair bills for their invaluable assistance in helping to continue the independent management of the Minnesota State Agriculatural Society by its staff and directors.

**Resolution No. 5:** Resolved, that we thank the print and broadcast media of Minnesota for their support through continuing efforts to publicize the events of the State Fair.

**Resolution No. 6:** Resolved, that we continue our association with the Minnesota Federation of County Fairs and the International Association of Fairs and Expositions, cooperating in mutually beneficial programs; and that we continue to support the University of Minnesota's Fair Management Short Course.

**Resolution No. 7:** REMAWLED, that the Society has suffered a deep loss through the deaths of the following individuals: Russell E. Dornseif, long-time service department employee and 50 Year Award winner; Lawrence F. Haeg, former board member, past president and honorary life member of the Society; Clement B. Haupers, former fine arts superintendent; and Albert J. Keller, retired greenhouse superintendent. Be it further resolved that our sympathy be extended to the families of these good men.

The society proceeded to conduct required elections with results as follows:

The preceding represent concessions at the State fair granted the privilege of selling 3.2 beer on other than a percentage basis. Reconcilement between the State Fair and these concessionaires is undertaken as follows: concessionaire pays to State Fair \$4.50 for each case of 3.2 beer sold and \$29.00 for each  $\frac{1}{2}$  barrel of tap/draft 3.2 beer sold. Beer sales are based on 24-12 ounce bottles per case, sold by concessionaire at a price of \$1.00 per bottle, including state sales tax. Tap/draft beer sales are based on the use of 12 and 20 ounce paper cups sold by the concessionaire at the price of \$1.00 per 12 ounce cup and \$1.50 per 20 ounce cup, including state sales tax.

Meeting was called to order at 9 a.m. by Chairman, Korff.

Messrs. Richard D. Young, Jr. and James Wall appeared before the committee to request review of the Space Rental Department's earlier decision denying them the opportunity to sell Viking and Paulared Apples from the concession space held by Appleside Orchards and Market in the Lower Grandstand. The earlier decision of staff had been based on the number, placement and distribution of other concessions contracted to offer apples at the Fair, but the committee felt that the sale of apples from this concession was complimentary to its intended purpose and the sale of apples from the location contracted to Appleside would not constitute any difficulty relative to the total presentation of this product on the grounds. Staff was asked to amend the space rental contract for Appleside to provide for the sale of Viking and Paulared apples at the 1983 Fair. Moved by Mr. Lund, seconded by Mrs. Roehlke and carried (Aye-3; Nay-0).

The Space Rental Application for Chee's Cafe was presented to the committee for review and the applicant, Mr. Wayne Chu, appeared to indicate that his interest in space at the State Fair was based on a desire to provide employment for students and help people in the same manner. Mr. Sinclair reviewed the subject application and indicated that the earlier staff decision denying Mr. Chu's request was based on a lack of physical space available in the area requested on the State Fairgrounds and staff concern for maintenance of good geographic balance and repetition of like products about the fairgrounds, as they relate to the number of concessions already offering similar food products. It was moved by Mr. Lund, seconded by Mr. Roehlke and carried that the earlier decision of the Space Rental Department relative to Mr. Chu's application be supported (Aye-3; Nay-0).

Mr. and Mrs. Petar Ivanic presented their thoughts to the committee regarding the department's earlier decision denying their appliction for a second concession location at the Fair to present a man-made chamois product. Mr. Sinclair advised that the department's decision had been based on the fact that Mr. and Mrs. Ivanic's firm, L.R. Company, already was contracted for concession space in the Fair's Creative Activities Annex to offer other products and that the number of new space applicants interested in obtaining space for the first time related to the amount of anticipated space available for the 1983 Fair would not allow the staff to grant a second operation space to L.R. Company. Moreover, it was noted that another concessionaire in the Creative Activities Annex was presently in possession of a 1983 Space Rental Contract providing for the sale of a similar chamois product. It was moved by Mr. Lund, seconded by Mrs. Roehlke and carried that the initial staff decision regarding L.R. Company's request for a second concession space be supported for the reasons indicated, but that Mr. and Mrs. Ivanic be allowed the opportunity to offer their chamois product if they would be willing to relinquish the space they held in the Creative

Activities Annex, discontinue the sale of the products they were contracted to offer in this location and explore alternative location possibilities in another building at the Fair where their chamois product might be presented in a compatible environment (Aye-3; Nay-0).

Upon a motion by Mrs. Roehlke, seconded by Mr. Lund and carried it was decided by the Space Rental Committee that the application of J.J. Grundy, Inc. to present an exhibit of insulated replacement windows and doors be denied. This action was in support of the staff determination regarding same, based on a lack of available contiguous physical space in an area suitable to present these products of a size appropriate to meet the indicated needs of the applicant, as well as based on committee concerns for good geographic balance and repetition of like products about the Fair, in relationship to the number of exhibits already contracted to offer generically similar products/services (Aye-3; Nay-0).

Ms. Betty Benjamin, President of the Abortion Rights Council of Minnesota met with the committee to request the review of a department decision refusing ARCM the opportunity to add t-shirts and balloons to the line of products they are allowed to sell from the space rented to them in the Lower Grandstand. The staff's earlier decision had been based strictly on the fact that the State Fair already has several concessions contracted to sell the subject generic groupings of products the Abortion Rights Council wished to add to their previously contracted line and their concerns for good geographic balance and repetition of like products about the fairgrounds in relationship to the number of concessions already offering generically similar items. Ms. Benjamin summarized the purpose of her organization, described the products they wished to offer in further detail and expressed concern that the sensitivity of the issues which surround her organizations may have had a bearing on the department's decision. Mr. Heffron examined correspondence the staff had received from legal council for the Abortion Rights Council and responded to the thoughts expressed in same. Ms. Benjamin was advised by staff and the committee that issues surrounding the purposes of her organization had no influence upon the decisions of either, that the interest and support her group had given the Fair was appreciated, along with their efforts to present their tenets to fair-goers and contribute to the State Fair as a forum for the presentation of varying ideas, thoughts and concepts, but that the prior concerns for good balance and repetition of like products about the Fair relative to the number of concessions already offering same would not allow the committee to permit further presentation of these same generic products. Moved by Mr. Lund, seconded by Mr. Sprengeler and carried (Aye-3; Nay-0).

The Space Rental Application submitted by Mr. John M. Sortland for the sale of Norweigian Sweet Dough Pizza by his firm, Specific Foods, was reviewed with Mr. Sortland by the Committee. Mr. Sortland described the process for making his product and the various ingredients involved. Concerns for reasonable geographic balance and duplication of similar pizza products about the fairgrounds, as they relate to the number of concessions already offering similar food/ pizza products were cited by the committee as factors which made the placement of Mr. Sortland's concession at the 1983 Fair difficult. It was moved by Mr. Lund, seconded by Mrs. Roehlke and carried that the application submitted by Specific Foods be denied based on the preceding concerns (Aye-3; Nay-0).

Mr. A. Paul Springer met with the committee to request review of the decision denying his application for space to show his attraction billed as the "World's Largest 6-Legged Steer". Mr. Sinclair indicated that Mr. Springer's application had been denied by staff for lack of space available in a size suitable to meet the applicant's indicated needs in an area of the fairgrounds appropriate to the presentation of such an attraction or one of the areas applied for by Mr. Springer. Based on the preceding, it was the determination of the committee that Mr. Springer's concession was of such a size that suitable space for its presentation at the State Fair could not be found at this time for the 1983 Fair. Moved by Mrs. Roehlke, seconded by Mr. Sprengeler and carried (Aye-3; Nay-0).

It was moved by Mrs. Roehlke, seconded by Mr. Sprengeler and carried, that despite the interesting nature of the products and services offered by Northern Hydraulics, Inc., as reviewed with the committee by Mr. Don Kotula, and the appreciation of the committee for Northern Hydraulics' methods of direct distribution to consumers at reasonable prices, lack of adequate available exhibit space in an area of the fairgrounds appropriate to the presentation of the subject products/services would not allow for the accommodation of this firm's request for display space at the 1983 State Fair (Aye-3; Nay-0).

Mrs. Phyllis Grotte requested review of the Space Rental Department's earlier decision denying her request for space to exhibit/sell Sasco Aloe Vera products and expressed concern regarding her receipt of inadequate response upon calling the State Fair for space rental information. The staff indicated that their denial of Mrs. Grotte's space application was based on their concern for repetition of Sasco products on the fairgrounds in relationship to the limited amount of available space for the 1983 Fair and the fact that the products Mrs. Grotte wished to offer were already being offered at the Fair. It was moved by Mrs. Roehlke, seconded by Mr. Sprengeler and carried that the earlier staff decision relative to the subject application be supported (Aye-3; Nay-0).

The application for concession space submitted by Jon V. Grotte for the sale of soup and sandwiches at the 1983 Fair was also considered by the Space Rental Committee. Mr. Grotte discussed with the committee the requirements of his operation and the flexibility of his menu. Committee concerns for good geographic balance and repetition of similar food products at the Fair, as related to the number of concessions already offering like food products would not allow the acceptance of Mr. Grotte's request for concession space to offer further soup and sandwich products at the 1983 Fair. Moved by Mrs. Roehlke, seconded by Mr. Sprengeler and carried (Aye-3; Nay-0).

Meeting adjourned at 12:15 p.m.

Mr. Sinclair indicated that the earlier decision relative to Mr. Sturzebecher's application had been based on staff concerns for maintenance of good geographic balance and repetition of like generic jewelry and toy products about the fairgrounds. Upon a motion by Mr. Ramberg, seconded by Mr. Lund and carried, the earlier staff action was supported by the committee (Aye-5; Nay-0).

The application for concession space by Peddler's Two, previously denied by staff, was placed before the committee for review based on a letter request from the applicants, Mr. & Mrs. V. Murphy. Mr. & Mrs. Murphy were unable to be present, but their application and correspondence requesting that space applicants offering products produced in the United States be given preferential consideration over those proposing the presentation of imported items was considered by the committee. Committee concerns for geographic balance and repetition of similar generic puppet, ceramic, wooden puzzle and novelty products would not allow for the acceptance of the Murphy's request for concession space to offer same. Moved by Mr. Lund, seconded by Mr. Tiffany and carried (Aye-5; Nay-0).

The Committee reviewed the concession space application submitted by Juel Fairbanks Chemical Dependency Services with the representative of this organization, Mr. Carlus Espejo. Mr. Espejo advised the committee that their concession proposal was based on a desire to raise funds to support the organization's service programs through the sale of American Indian ethnic foods. It was moved by Mr. Ramberg, seconded by Mrs. Roehlke and carried that the subject application should be placed by staff in an "if suitable space becomes available" status to be given further consideration by staff between this date and the Fair should space appropriate to the presentation of this concession become available (Aye-5; Nay-0).

The request of Gene and Harriet Will to transfer their ownership of the peanut concession structure they operated at the 1981 and 1982 State Fairs on lot S-1 in block 49 to Charles and Arta Cheney was approved on a motion by Mr. Tiffany, seconded by Mrs. Roehlke and carried (Aye-5; Nay-0).

Mr. Sinclair reviewed with the committee staff correspondence with Fair Home Company, Inc. and its partners Messrs, Paul R. Larson and Gary E. Lego relative to the status of the earth sheltered home structure as an exhibit for the 1983 State Fair, the outstanding monetary obligations from completion/presentation of this exhibit and the potential disposition of same in preparation for the 1983 Fair. Mr. Brad Engdahl, representative from the Minnesota Attorney General's Office, discussed possible legal recourse for resolution of the matter along with possible steps which might be taken by the State Fair relative to disposition of the structure. No action appropriate at this time.

Departmental payroll schedule for 1983, as prepared by superintendents under budgetary guidelines and confirmed by appropriate coordinators, were approved in a motion by Mr. Ramberg, seconded by Mr. Lilliquist and carried (Aye-8; Nay-0).

A progress report on the establishment of a trust association was introduced by Mr. Frost. Alternative legal structures which might be utilized in the formation of such a trust were discussed. Also reviewed was the statutory authority necessary for implementation of the trust. Action was delayed pending further specific information on the subject.

Upon a motion by Mr. Ojakangas, seconded by Mr. Morris and carried, approval for payment of the following three (3) storage damage claims was granted: A.A. Danna, vehicle paint damage, \$617.50; C.S. Flynn, torn boat canvas, \$25.00; J.D. Strauss, damaged boat canvas, \$96.20 (Aye-8; Nay-0).

Mr. Frost updated the Board on the Fair's 1983 sponsorship program indicating that approximately \$35,000 would be realized in direct income from various commercial companies along with advertising/promotion commitments for radio, TV and newspaper placement. Total benefits from the program should exceed \$70,000.

It was moved by Mr. Lund, seconded by Mr. Ramberg and carried that the liablilty and director/officer insurance coverage of the exposition be increased to \$5 million. Added premium for this coverage would be approximately \$9,000 per year (Aye-8; Nay-0).

A non-budgeted expenditure of \$7,500 to upgrade forage barn facilities so as to accommodate a 4-H poultry show, including lights, ventilation and tables, was approved on a motion by Mr. Tiffany, seconded by Mr. Ojakangas and carried (Aye-8; Nay-0).

A fully detailed report on Society acquisition of a 7.14-acre parcel of land and 13 buildings on the south side of Como Avenue, across from the Canfield Gate, was provided by Mr. Frost. Authority for staff to proceed with purchase of this parcel, known as the "Sussel Property", was granted via a mail ballot of the Board on April 26, 1983 (Aye-10; Nay-0). After lengthy review and discussion, it was moved by Mr. Ramberg, seconded by Mr. Tiffany and carried to approve (1) the acquisition as outlined and (2) debt commitment to Norwest Bank of \$974,000 at a floating interest rate of 75 percent of prime (Aye-8; Nay-0). It was further moved by Mr. Lilliquist, seconded by Mr. Morris and carried that staff be authorized to lease (through an agency) two structures on the site so as to amortize a portion of the interest due on the debt (Aye-8; Nay-0). Sale of nine acquired but surplus structures through a formal bid procedure with proceeds of \$12,960 was approved upon a motion by Mr. Korff, seconded by Mr. Ojakangas and carried (Aye-8; Nay-0).

Brad Engdahl, special assistant attorney general assigned to represent the Society, was introduced by Mr. Sprengeler and welcomed by members of the Board.

Upon a motion by Ms. Roehlke, seconded by Mr. Lilliquist and carried, approval was granted to issue the administrative employee coffee fund (Steve Pooch) \$50.00 to cover coffee used during the summer and during the fair by business visitors (Aye-8; Nay-0).

Mr. Sprengeler set an agenda call for the next meeting of the Board on Friday, August 26, 9:00 a.m.

Meeting was called to order by Chairman Korff at 9:05 A.M.

On a motion by Mr. Lund, seconded by Mrs. Roehlke and carried, the ticket price for rides on the giant carrousel was increased from  $50\phi$  to  $75\phi$  for the 1983 Fair per request by the operators of this attraction, Brede Carrousel, Inc. (Aye-2; Nay-0)

A request by Mr. and Mrs. Richard L. Mockler to transfer ownership of the peanut concession structure they operate on lot E-1 in block 43 to Ms. Diane V. Leech was approved on a motion by Mr. Lund, seconded by Mrs. Roehlke and carried (Aye-2; Nay-0).

Transfer of the structure known as the "dome home", located on lot EE in block 44, from The Outdoors People, Inc. to Daystar Shelter Corporation was approved by the committee with the understanding that said structure, though operated under a concession space rental contract, would remain a commercial exhibit for the purpose of promoting dome home living, and that the admission fee for entry into this structure would remain 50¢. Moved by Mrs. Roehlke, seconded by Mr. Lund and carried (Aye-2; Nay-0).

Mr. Sinclair reviewed with the committee the status of the Fair's relationship with Mr. Paul R. Larson relative to the earth sheltered home exhibit, his payment of outstanding obligations incurred from presentation of this exhibit at the 1982 Fair, plans to provide for payment of same and continued operation of this exhibit in 1983.

Mary Schirmer met with the committee to request review of the Space Rental Department's decision denying her application for a concession location to sell fruit tostadas, a food product generically similar to funnel cakes. Mr. Sinclair indicated that the department's earlier decision had been based on simple lack of sufficient available space to accomodate this request. Walter Schirmer expressed concern that preferential treatment was being given to concession/exhibit applicants from out of state, to multiple concession operations and at the number of concessions presenting similar products. Mr. Heffron explained the status of the Board's position relative to multiple concession operations and the staff's efforts to observe same and advised the Schirmers that the point of a concession/exhibit's origin and acceptance or denial based on same was seldom an appropriate approach to the process of space allocation with the best interests of the public being first in mind. It was moved by Mr. Lund, seconded by Mrs. Roehlke and carried that previous action of staff be uphelded (Aye-2; Nay-0).

The committee reviewed the space rental application submitted by Ms. Elizabeth Lehmann. Mr. Sinclair indicated that Ms. Lehmann's application had been one which the staff had a desire to place based on the high quality of the products, but that suitable space had not become available for the 1983 Fair which lead to denial of Ms. Lehmann's space request. Based on the quality of Ms. Lehmann's product lines and their minimal representation at the Fair, it was moved by Mr. Lund, seconded by Mrs. Roelke and carried that the staff give Ms. Lehmann's space request every possible further consideration should appropriate space become available for such an operation between this date and the 1983 Fair (Aye-2; Nay-0).

Messers. Jack Mueller and Robert Hansen presented their product, "Locker Mate", to the committee requesting review of the Space Rental Department's decision denying them space to present same at the 1983 Fair. Mr. Sinclair advised that the department's inability to accomodate Messers. Mueller and Hansen's request on behalf of their company, Sioux Technology, Inc., had been based on the late date of their application submission and the lack of available, suitable space at the time of application receipt. Based on the quality and unique nature of the subject product it was the determination of the committee that this application should be given further consideration for space should same become available between this date and the Fair. Move by Mr. Lund, seconded by Mrs. Roehlke and carried (Aye-2; Nay-0). It was moved by Mr. Lund, seconded by Mrs. Roehlke and carried that the action of staff denying the application for rental space submitted by Reimer Publication, Inc. be supported based on the late date of application receipt and the lack of available space to accomodate said request (Aye-2;

Nay-0).

In order to avoid placing any concession operator in a difficult operating position, it was determined that staff should continue to appraise such requests based on their individual circumstances.

Mr. Heffron read a letter over his signature addressed to Messrs. Fernando La Brada and Victor Elliot, the principals of Mexican Villages, Inc. The text of his correspondence summarized the administrative decision made to discontinue this concession which had operated at the State Fair since 1970 in order to put the area to use for other purposes. Correspondence from Mr. La Brada requesting review of the staff's decision was presented to the committee with the understanding that a date would be set for review subsequent to December 1, 1983.

Mr. Sinclair presented a brief report of 1983 Space Rental Department operations reflecting total receipts of \$1,743,132.68 which is \$163,330.60 over 1982 income and \$143,132.68 above budget estimates. Of this revenue, 92 percent came from the 760 concession contracts and eight percent from the 356 exhibit contracts executed. Beer sales reflected a \$22,987.92 revenue increase over this source in 1982 based on increased volume of beverage sold. With two exceptions, (the antique boat show and haunted house), all percentage attractions showed an increase in receipts; included was the carnival which individually showed an approximate 10 percent (\$35,795.32) increase from rides and shows. Increased concession revenues were also attributed to a program instituted in 1983 where the State Fair dealt directly with contracted Grandstand entertainers to receive 15% of the revenue from artist merchandise sales. The fair received \$23,328.76 from this source during the 12 day fair.

It was moved by Mr. Ramberg, seconded by Ms. Roehlke and carried that secretary be authorized to adjust staff salaries effective the pay period commencing December 24, 1983 (Aye-8; Nay-0).

A review of fair-period payrolls was undertaken, after which it was moved by Mr. Tiffany, seconded by Mr. Ojakangas and carried that the payroll summary (\$845,054.41) be approved as submitted (Aye-8; Nay-0).

Secretary outlined the history and potential impact of a recent legislative enactment, which adds the following language to Chapter 37, Section 37.19: "A contract between the society and an entertainer shall not prohibit the entertainer from performing at a location more than 80 miles from the state fair-grounds during the state fair or within 30 days before or after the state fair." Mr. Frost provided a short resume of the contract negotiation process used in signing talent plus a specific review of the difficulty, risk and inherent discrimination con-

tained in the added language. After discussion, it was agreed (without formal action) that secretary be authorized to seek legislative repeal of the subject enactment as soon as practical.

A revision of the State Fair purchase/disposal plan, reflecting certain provisions of current state purchasing policy, was approved upon a motion by Mr. Ramberg, seconded by Mr. Annexstad and carried (Aye-8; Nay-0).

Mr. Frost submitted an updated report on the milking parlor construction project, indicating that bid advertising was placed November 11 with bid opening scheduled for December 2. A final report on cost and contract details will be submitted to the Board as a part of budget considerations in January. No actions required at this time.

Secretary reminded the Board that a single opening for election to the Society's "Life Membership" would come before the Annual Meeting in January. After discussion, it was moved by Mr. Lilliquist, seconded by Mr. Ramberg and carried that Mr. Jerry Franke's name be recommended for election to Life Membership (Aye-8; Nay-0).

#### SPACE RENTAL COMMITTEE MEETING Administration Building, State Fairgrounds

#### Monday, December 12, 1983 – 9:00 A.M.

Members present: Korff, Chairman; Ramberg; Roehlke; Ojakangas; Heffron, ex officio; Wenzel, ex officio; Sinclair, ex officio.

Also present: Fernando LaBrada and Victor Elliot, Mexican Villages, Inc. and Sam Berman (an attorney representing Mr. LaBrada).

Meeting was called to order at 9:00 a.m. by Chairman Korff.

Mr. Sinclair briefly reveiwed correspondence between the Minnesota State Fair and Mexican Villages, Inc. dated October 24, 1983 in which Mexican Villages, Inc. was advised that an administrative decision had been made to discontinue the Mexican Village concession and entertainment area at the Minnesota State Fair. Mr. LaBrada responded on November 9, 1983 requesting review of this decision.

Mr. LaBrada requested that the committee consider an extension of Mexican Village operations through the 1984 Fair in order to allow participating exhibitors greater opportunity to plan for the discontinuance of Mexican Village. As an alternative, Mr. LaBrada suggested that should a one year continuance be impractical, that Mexican Villages, Inc. be allowed to rent as concessionaires a portion of the new themed area.

Mr. Heffron indicated that based on the year to year contractual relationship with all concessionaires, including Mexican Villages, Inc., the Fair had provided earlier than normal notice of the Fair's intention to make a change in this area and that plans were already in place for physical and entertainment changes for 1984. Mexican Villages, Inc. was advised that they or any of the concessionaires whom had previously held space in Mexican Village would be given the opportunity to apply for space at the 1984 Fair upon submission of an appropriate application request.

Mr. Ojakangas confirmed the Fair's appreciation of the efforts of Mexican Villages, Inc. since 1970 in presentation of a fine attraction. He also expressed a concern over the amount of exhibit and product duplication in Mexican Village.

Mr. Ramberg reiterated the Fair's appreciation of the Mexican Villages success beyond its originally anticipated years and voiced an interest in seeing that a change be made in the subject area in order to meet changing fair audience or market demands and to provide for future planning which mandates occasional changes in the exposition format.

Mr. Korff repeated that any past Mexican Village exhibitor would be given the opportunity to apply for concession space at the 1984 Fair as a new space applicant upon requesting application materials and Mr. Sinclair explained the process of new application distribution and review based on Mr. Berman's inquiry.

It was moved by Mr. Ramberg, seconded by Mr. Ojakangas and carried that the administrative decision to discontinue presentation of a Mexican Village at the Minnesota State Fair be supported and that staff continue with the formulation of alternative plans for use of the area at the 1984 State Fair (Aye-3; Nay-0).

Meeting was adjourned at 9:40 a.m.

#### **1983 STATE FAIR SUMMARY**

The 1983 State Fair attracted 1,347,884 visitors during its 12day run Aug. 25 through Labor Day, Sept. 5. That total is the sixth-highest attendance figure in the history of the exposition and represents an increase of 26,099 over 1982's attendance.

A single-day admission record was set Friday, Sept. 2, when 116,566 people attended the fair. The previous standard of 115,368 was established in 1982.

The '83 State Fair will be remembered for the unusually warm weather that persisted throughout most of the exposition. The average high temperature was  $85^{\circ}$ ; on four days, temperatures topped 90.

Weather during the fair was also wetter than usual, with rainfall recorded on nine of the fair's 12 days. With the exception of the fair's final weekend, though, most of the rain fell during late night or early morning hours and did not affect attendance or interfere with activities. Total rainfall for the fair was measured at 2.61 inches.

Admission to the fair was \$3.25 for adults 16 and over, \$1.50

for children 5 through 15 and free for children under 5. Discount gate admission tickets were available for \$30 per book of 12 (\$2.50 per ticket). Parking in all official State Fair lots, on and off the grounds, was free.

In June, the State Fair purchased 7.14 acres of land from The Sussel Company, Inc. The land is across Como Avenue from the southwestern corner of the fairgrounds and gives the exposition an additional 1,000 parking spaces, increasing the fair's total parking capacity to 13,184 vehicles.

Senior citizens, children, bicyclists and bus riders were all given special consideration during the exposition. Both Thursdays of the fair were Senior Citizen Days when persons 65 and over were admitted free. Fridays were Children Days and Pepsi Bicycle Days. Kids 15 and under were admitted free and adults who rode a bike to the fair were admitted for \$1.50. Every day of the fair, adults who rode a regularlyscheduled MTC bus to the exposition were given a 50-cent discount on outside gate admission.

#### **Report Summary**

#### August 1984

The Office of the Legislative Auditor has released an audit report on the State Agricultural Society for the year ended October 31, 1983. The major objective of this annual audit was to express an opinion on the Society's financial statements for the fiscal year. As a result of our audit, we have issued an unqualified opinion on those financial statements. Our audit also included a review of the Society's system of internal accounting controls. This review disclosed no material weaknesses or other problems in the internal control system.

We made one recommendation in our report, concerning the Society's mandated financial reporting process. Currently, in order to comply with Minn. Stat. Section 37.06, the Society issues a series of documents and reports each year. Streamlining this reporting process would eliminate the potential for conflicting sets of financial statements included in the various reports, while still achieving adequate information and disclosure to interested parties. We therefore recommended that the Society pursue legislation to clarify and simplify their mandated financial reporting requirements. The Society is currently reviewing the applicable laws to determine if a statute change is appropriate.

#### INTRODUCTION

The State Agricultural Society, established under the authority of Minn. Stat. Chapter 37, is the organization responsible for holding the annual State Fair. The Society is composed of members of agricultural societies which hold annual fairs, delegates from counties where no agicultural society exists, honorary members as the result of eminent service in agriculture, and delegates from various agricultural associations. The management and control of the affairs of the Society is vested in a board of managers consisting of a president and nine other members. The Secretary-General Manager is responsible for administration of the State Fair, and reports to the board of managers. Michael D. Heffron has served as Secretary-General Manager since October 1, 1976. The organization of the State Fair has been divided into three divisions; the Public Affairs Division, the Operations Division, and the Finance Division.

The Society has operated a State Fair since 1859. These fairs have been held at various locations, and in 1885 Ramsey County donated a 200 acre site to the Society. Additional land was purchased at various periods of time, resulting in a total of over 300 acres in 1983. Since 1949, the State Fair has been self-sustaining and has invested over \$9 million in the fairgrounds. The State Fair has grown so that in 1983, receipts totaled \$6,969,371 with an attendance of 1,347,884 persons.

## FINANCIAL SECTION

The financial statements and supporting schedules in this report are presented exactly as they appeared in the Secretary's Report to the Annual Meeting of the Minnesota State Agricultural Society, issued in January 1984, except for the following:

- 1) Footnote ten, pertaining to the Minnesota State Retirement System, has been added. Disclosure of participation in pension plans is required by generally accepted accounting principles.
- 2) Footnote one has been deleted. That footnote no longer applies since it informed readers that, at the time the Secretary's Report was issued, the financial statements were unaudited.

Our examinations were made in accordance with generally accepted auditing standards and, accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

In our opinion, the financial statements referred to above present fairly the financial position of the State Agricultural Society as of October 31, 1983 and 1982, and the results of its operation and the changes in its financial position for the years then ended, in conformity with generally accepted accounting principles applied on a consistent basis.

The Supplemental Schedule of Revenues and Expenses for the fiscal years ended October 31, 1983 and 1982 is presented for supplementary analysis purposes and is not necessary for the fair presentation of the financial statements of the State Agricultural Society in conformity with generally accepted accounting principles. This schedule has been subjected to the tests and other audit procedures applied in the examination of the basic financial statements and, in our opinion, is fairly stated in all material respects in relation to the basic financial statements taken as a whole.

#### NOTE 2 - CHANGE IN FISCAL YEAR

In 1982, legislation was passed changing the fiscal year of the Society from December 1 through November 30 to November 1 through October 31. This change necessitates the one-time reporting of financial activity for an 11-month period; 1982 statements reflect activity of the Society from December 1, 1981 through October 31, 1982.

#### NOTE 3 - SUMMARY OF ACCOUNTING POLICIES

Assets and liabilities and income and expenses are recognized on the accrual basis of accounting. Fixed assets are stated at cost less accumulated depreciation. Donated materials and services are valued at their estmated fair value at the date they are donated. Expenditures for maintenance and repairs are charged to expense as incurred. Costs of newly acquired items, including renewals and replacements which add to the original value or materially extend the useful lives of the related assets, are capitalized and written off as depreciation charges over their estimated useful lives. Costs of assets and the related accumulated depreciation are eliminated from the accounts in the year of sale or retirement. Depreciation is computed on the straight-line method over the estimated useful lives of the assets. The provision for depreciation is calculated based on the following lives:

#### NOTE 7 – DEFERRED INCOME

The accounting method of recognizing off-season storage income was changed beginning fiscal 1983. The current method recognizes income when earned as opposed to the former method of recognizing income when received. The difference between revenue received and unearned is shown as a current liability. The effect of this change is decrease net income for fiscal 1983 by \$12,433.71. The accompanying financial statements for 1982 have been restated to reflect an increase in 1982 net earneings of \$4,670.46 and reduce cumulative retained earnings on December 1, 1981 by \$72,954.75.

#### NOTE 8 - CONTRACT FOR DEED PAYABLE

The contract is dated November 30, 1979, and the rate of

interest is six percent. The contract is to be paid in not more than 17 annual installments, each of which shall be equal to or exceed the greater of the following amounts: the interest due on the unpaid balance, or 33-1/3 percent of the gross annual receipts generated by University of Minnesta parking on fairgrounds lots per existing agreements.

#### NOTE 9 – NOTE PAYABLE

The note is payble to Norwest National Bank of St. Paul and represents interim financing for the purchase of 7.14 acres of land adjacent to the fairgrounds. The rate of interest is 75 percent of the prime rate and is payable monthly. The note is due June 23, 1984, and, at that time, an agreement for long-term financing will be arranged.

#### NOTE 10 - MINNESOTA STATE RETIREMENT SYSTEM

All Society full-time employees (temporary employees from July 1 through October 15 are specifically excluded by Minn. Stat. Section 352.01, Subd. 2B) must participate in the State Employees Retirement Fund, which is administered by the Minnesota State Retirement System (MSRS). Contributions are made to the fund by employees and the Society based on a percentage of gross salary. The Society matches the employees contribution and also pays an additional amount to retire prior years unfunded liabilities. Full funding is required by the 2009. Due to legislative action the contribution rates have changed several times in recent years. The date of change and the new rates are shown below.

#### **CURRENT FINDING AND RECOMMENDATION**

# Changes are needed in the State Agricultural Society's mandated financial reporting process.

In order to comply with Minn. Stat. Section 37.06, which outlines their mandatory reporting process, the State Agricultural Society issues a series of documents and reports each year. First, Minn. Stat. Section 37.06 requires the Society's secretary to make a report to the Governor, on or before December 31 each year, for the fiscal year ended October 31 of that year. This report, referred to as the "Report to the Governor" shows all the proceedings of the Society for the year and its financial statements. The Legislative Auditor is required by statute to perform an annual audit of the Society. Our report also contains the Society's financial statements along with our opinion on them. This audit has historically been conducted in the early spring. The results of our audit, including the statements are appended to the Report to the Governor along with the proceedings of the Society's annual meeting, and published as the Annual Report of the State Fair ("Annual Report"). Therefore, the Annual Report contains two sets of statements, one set unaudited and one set audited. This Annual Report format is required by Minn. Stat. Section 37.06. Finally, in addition to these reports which are mandated by statute, the Society also publishes a report called the "Secretary's Report to the Annual Meeting," which is held in January of each year. This report is intended to provide information to the members and contains a set of unaudited Society financial statements.

Although the Society is complying with Minn. Stat. Section 37.06 regarding their reporting procedures, the current process is cumbersome and it raises several concerns. First, the existence of these various reports containing financial statements could be very confusing for financial statement users. In the past, both our office and the Society have made slight changes to the original financial statements for inclusion in each subsequent report, creating inconsistency among the reports. Also, our audit opinion has been traditionally included in the Annual Report without our involvement in proofing the included financial statements, which we are professinally required to do.

Ultimately, we believe the Society should issue only one formal published general purpose report which would include the financial statements and our audit opinion. If the report were timely, it would eliminate the potential for conflicting sets of financial statements while still achieving adequate information and disclosure to Society members, the Legislature, and other interested parties. In that case, we would no longer need to include financial statements within our audit report, but rather could include our audit opinion directly in the Society's report when it was published. Hopefully, such a report could be issued between two and six months after the Society fiscal year end, October 31.

A statutory change clarifying the Society's reporting requirements would be required before these various mandated reports could be consolidated or eliminated. Although both we and the Society have long recognized this problem, until new legislation is enacted, the confusion concerning the Society's financial reporting will continue to exist.

#### **RECOMMENDATION:**

1. The State Agricultural Soceity should pursue legislation to clarify and simplify their mandated financial reporting requirements.

## STATUS OF PRIOR AUDIT RECOMMENDATIONS AND PROGRESS TOWARD IMPLEMENTATION

## Deferred revenue is not recognized for receipts from off-season vehicle storage.

1. Receipts received from vehicle storage should be prorated over the rental period and the appropriate amount recorded as a deferred revenue on the financial statements at year-end. Recommendation Implemented.

## Insurance expense is not properly accounted for in the Society's financial statements.

2. Prepaid insurance expense should be recorded on the balance sheet at year-end for paid premiums covering any future fiscal years.

Recommendation Implemented.

## Internal controls over the public safety unit's payroll system need to be strengthened.

3. Time reports for the employees of the public safety unit should be signed by the payroll clerk who prepares them. If possible, someone independent of the payroll and personnel units should, on a sample basis, compare the hours worked per the log sheets to the hours actually paid.

Recommendation Implemented.

Provided herewith is a response to the recommendations contained in your preliminary audit report of the Minnesota State Agricultural Society for the year ending October 31, 1983.

As requested in your cover letter, we would be happy to provide your agency the opportunity to review printer's proofs of the financial section of our Annual Report before publication. You will be notified by Mr. Roehl when these draft documents are available.

We appreciate the careful analysis contained in your recommendation on the Society's financial reporting process and agree that current statutory requirements in this regard are cumbersome. Our Special Assistant Attorney General (John Galus) is being asked to review the statute and your recommendation and, if appropriate, to aid in the reframing of section 37.06 for legislative consideration. Obviously, these matters must pass before our Board for its approval before any specific action may be undertaken.

Statutory update, regardless of how concise, cannot change one fact: The Society's Annual Meeting must be held in January and, at that meeting, management must present a financial report for consideration and acceptance. We respectfully suggest that your agency consider scheduling the annual audit to allow for inclusion of audited financial statements with the "Society Secretary's Report" published in January. We realize that because of publication deadlines, the timing of audit work would be of the essence. However, with Society Staff assistance, we believe publishing requirements could be met.

Inclusion of audited statements in the Secretary's Report would eliminate the need to publish unaudited financial statements. Thus, all printed reports would contain uniform financial disclosure.

We appreciate your generous cooperation in dealing with Society fiscal matters. If I can be of assistance in the ongoing audit process, please let me know.

#### ANNUAL MEETING MINNESOTA STATE AGRICULTURAL SOCIETY Radisson Hotel – St. Paul, Minnesota January 15-17, 1984

The 125th annual meeting of the Minnesota State Agricultural Society got under way with a day-long registration session on Sunday, January 15 (registration continued Monday, January 16 and Tuesday, January 17). First general business session, chaired by President Sprengeler, was held at 9:15 a.m. Monday for the purpose of appointing credentials and resolutions committees; these committees met to conduct business at 10:15 a.m. Monday.

At 3:00 p.m. Monday, delegates from the first, third and sixth regional districts met in caucus to certify nominees for election to the Society's board of managers on January 17.

At 1:00 p.m. Tuesday, members of the Society again met in general session. President Sprengeler called the meeting to order; reports of Secretary-General Manager Heffron and Controller Roehl were presented and accepted.

Remarks were given by Minnesota 4-H President Merle Buyck, Garvin, and Minnesota FFA President Thomas Pierson, Woodstock.

The following credentials committee report was presented by Donald Kienholz, Bird Island, and accepted by the membership:

"All credential blanks for statewide societies and associations submitted to the State Agricultural Society have been viewed by the committee and approved with the following exception: Minnesota Federation of County Fairs (did not file a report with the Secretary of State).

Resolutions committee report was given by William Binger, Cambridge. The following resolutions were adopted by the membership:

- No. 1 RESOLVED, that we believe the Minnesota State Fair to the finest institution of its kind in North America.
- No. 2 RESOLVED, that the Minnesota State Agricultural Society, as presently structured by state statutes, is eminently qualified to manage and operate the State Fair and State Fairgrounds through its board of managers, general manager, full-time staff, department superintendents and their employees.
- No. 3 RESOLVED, that in addition to the above persons we owe our thanks to many other individuals and groups for their part in the production and promotion of the annual State Fair. This group includes commercial exhibitors and concessionaires, competitive exhibitors, suppliers and purveyors, media and advertising representatives, public officials, county fair personnel, youth groups, chambers of commerce, implement dealers and manufacturers, entertainers and their agents and managers and agricultural producers and processors.
- No. 4 RESOLVED, that we appreciate that the most important State Fair group of all is the fair-going general public. It is this group we will endeavor to continue to serve with a high quality, economically priced package of attractions.
- No. 5 RESOLVED, that we continue our association with the Minnesota Federation of County Fairs and the International Association of Fairs and Expositions, cooperating in mutually beneficial programs; and that we continue to support the University of Minnesota's Fair Management Short Course.
- No. 6 RESOLVED, that management of the State Fair ought not be competitively hampered by a restrictive law relating to booking of entertainment, and that we support an effort to secure legislative relief of such restriction.
- No. 7 RESOLVED, that the Society has suffered a deep loss through the deaths of the following individuals: Mrs. Katie Little and Mr. Fred O'Neil, long-time food concessionaires; and Mr. Leo Overland, long-time thrill show and demolition derby producer.

BE IT FURTHER RESOLVED that our sympathy be extended to the families of these good people.

No. 8 – RESOLVED, that horse and dog shows are an important aspect of 4-H competition; therefore, 4-H and State Fair staffs and representatives of 4-H horse and dog interests shall meet to explore the possibilities of including this competition as part of the annual State Fair and a report of such meeting shall be made to the annual meeting of the society in 1985.

The Society proceeded to conduct required elections with results as follows:

Arthur Sprengeler, Plato, president, one year term. Leonard Ramberg, Minneapolis, vice president, fifth regional district, two year term. William Korff, Faribault, manager, first regional district, three year term. Eileen Roehlke, Rogers, manager, third regional district, three year term. Howard Morris, Cokato, manager, sixth regional district, three year term. Gerald Franke, St. Paul, honorary (life) member of the Society. Waino Kortesmaki, Edina, State Fair Hall of Fame. Mayme Green, St. Paul, State Fair Hall of Fame.

There being no further business, the 125th annual meeting of the Minnesota State Agricultural Society was adjourned.
